Volunteers purchase items from the resident's wish list, and these gifts are delivered by the ombudsman to the nursing home resident.

In addition, the Nursing Home Ombudsman Agency asks for donations of new, unwrapped nonskid socks, individually-wrapped snacks, word search and puzzle books, fleece blankets, and adult coloring books, coloring pencils, and pencil sharpeners. Charity Fraud Scams: How to Protect Yourself

The holiday season is the most popular time for charity fraud scams. The Federal Trade Commission offers tips on how to protect yourself and give without worry.

- 1. Do your research-
 - Check online resources like BBB Wise Giving Alliance, CharityWatch,
 - Charity Navigator, and Guidestar
 - Verify donation is tax-deductible by using IRS' Tax Exempt Organization Search
- 2. Be Careful how you pay
 - Avoid cash donations
 - Use check or credit cards
 - Never use gift cards or wire money
- 3. Watch out for scammers' tricks
 - Don't let anyone rush you
 - Scammers may thank you for donations you haven't made to trick you
 - Scammers may claim that donation is tax-deductible
 - Promising sweepstakes wins in exchange for donation is illegal
